Final Four NCAA game played on or about Monday, April 3, 2023.

Donors/participants notified by email of winner of GiveAway on or about Tuesday, April 4, 2023.

A check will be issued in the mail from the Rotary Club of Chestnut Hill Foundation (sponsor) on or about April 10, 2023.
